## **COMMENTS FROM CITIZEN:**

Mr. Dan Geschke-802 Romine, describes two accidents that occurred at his house. A car came down Romine this past Sunday morning at 5:00 a.m. and the vehicle hit his house, with the driver falling out. He stated that quite a few years ago there was a stop sign on the telephone pole at the end of Romine where the bend is. It is no longer there. There is still one at Elmwood. Those drivers coming up the hill don't stop. He asked if a traffic study could be done to address a one way on Romine Avenue from the old school one way going down and one way going up Elmwood to Washington boulevard. Mr. Lombardo said we would look into it. Mr. Tortorice said we can turn it over to the Engineer for review.

Tracie Magiesky-917 June Drive, is here this evening about the dirt bike riding again. She said they are now in the back yard now. She asked what Council can do, there has to be a noise ordinance and these kids under 16 years old. She said her and Denise Potter are prisoners of their home, because it's so loud. She wants to know what the police can do about this. She said it all times of the day, before, during and after school. She said they go down June Drive, get on McClure Street and then go where ever. She also said they are violating the ordinance for dirt bikes, kicking up dirt. Solicitor McGrail said we do not have a device to measure the noise level. Solicitor McGrail said they can't trespass on your property. She advised for Ms. Magiesky to call the police when they are riding on a street. She said she has called in the past and then they are back to riding in their yards. She said she can't catch them but the tracks from their dirt bikes are in her yard. General discussion on this matter. Mr. Tortorice said this is a police issue and she needs to contact the police when this occurs. He asked Chief Petruski to check this out to see if it can be worked out.

<u>Margaret Mansfield</u>-1028 Glenn Avenue, is here this evening about a vacant property on Weldon Avenue. She said there's pallets and tree stumps and wood stored there. Manager Migliori said she turned this over to the Building Inspector and he stated that there's nothing in our ordinances that prevent him from storing or selling the wood at that location.

<u>Rick Zahorchek-</u> 1710 Stegman Street, is here this evening inquiring on the paving status of Stegman Street. He said the only way he can access the property is through Dart Alley, and it's becoming increasing difficult because it's completely deteriorated. Mr. Lombardo stated that it's on the paving list for this year. Hopefully in June or end of May.

<u>CODE ENFORCEMENT OFFICER'S REPORT:</u> Mr. Hresko stated he and the Chief are driving throughs the Borough and keeping track. Mostly it's high grass and garbage.

**ENGINEERS REPORT**: Gave his report at the caucus meeting.

<u>CHIEF OF POLICE REPORT</u>: Chief Petruski reported on a new program full of resident resources that will start in April or May. The program is called Pass it On.

MAYORS REPORT: Mayor Hranics gave the statistics for March 2022.

The Mayor had the following report for April 6, 2022. The police had 143 calls in March, there were 12 traffic citations, 7 non-traffic citations, 22 assisting other departments and 16 calls assisting E.M.S., the balance of the calls were for various reasons such as animal complaints, disabled vehicles, disturbance, etc. The Mayor also reported the mileage on the 2021 Ford Explorer was 1,520 and no expenses, the mileage on the 2019 Ford Explorer was 1,976 and no expenses, the mileage of the 2017 Ford Explorer was 1,496 and no expenses.

**ENGINEERS REPORT:** Mr. Glenn gave his report at the Caucus Meeting.
