This regular meeting of Council was called to order on the above-stated date at the abovestated time after the Pledge of Allegiance by President Mark D. Tortorice with the following Members of Council present:

President Tortorice announced an Executive session was held this evening at 5:45 p.m. to discuss personnel issues.

Mrs. Thomas announced the meeting minutes for October 20, 2021 were not available for approval by meeting time.

COMMENTS FROM CITIZEN: Manager Migliori stated no comments received.

CODE ENFORCEMENT OFFICER'S REPORT: Mr. Hresko said no change to the report given in Workshop.

**ENGINEERS REPORT:** Gave his report at the Workshop meeting.

MAYORS REPORT: Mayor Hranics gave the October report.

The Mayor had the following to report for October, 2021. The police had 123 calls in October, there were 11 traffic citations, 9 non-traffic citations, 6 assisting other departments and 18 calls assisting E.M.S., the balance of the calls were for various reasons such as animal complaints, disabled vehicles, disturbance, etc. The Mayor also reported the mileage on the 2013 Ford Taurus was 587 and no expenses, the mileage on the 2017 Ford Explorer was 1,667 and expenses were \$64.95, mileage on the 2019 Ford Explorer was 1,314 and no expenses.

SOLICITORS REPORT: Solicitor Patricia McGrail stated she has prepared a Covid 19 policy for everyone and has prepared the recreation documents requested.

<u>FiNANCE/BUDGET COMMITTEE</u>: Mrs. Thomas gave the budget and tax report for October. 2021. October current tax collections \$6,987.80 October delinquent tax collections \$6.428.27

Budget and Finance committee met on Thursday, October 28<sup>th</sup>. We have come up with a preliminary draft to present to Council this evening. The total for the 2022 budget is 1,744,137.21. We are in a good financial position. The shortage we encountered when preparing the 2022 budget will be transferred over from the Capital Reserve account to cover the expenses. Overall, the budget has decreased from last year by \$112,000.00. This is due to good financial management and the grants brought in through out the year. The grants have helped defer some of the capital projects that were ear marked for budget expenses. The allocated transfer from the Sewer fund to balance the 2021 Budget will not be necessary according to the financial projections. I would recommend to advertise to display the preliminary budget for review along with the budget ordinances.

We are also applying for additional grant funding for demolition. We are currently waiting on the asbestos surveys of 1818 Tacoma, 1820 Tacoma, 1124 Burbank and 1706 New York Avenue. Glenn Engineering will prepare a bid proposal for the demolition.

Malisa is working on the next round of CDBG for street reconstruction and demolition, so if you get a call from the Borough it's completely legitimate and part of the survey process for funding.
